
This report is, above all, a heartfelt thank-you to the 1,017 donors who contributed more than \$1.8 million this year.

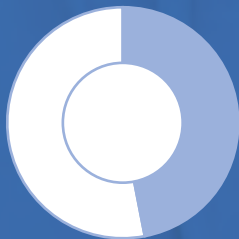
